### **UNAUDITED OPERATING STATISTICS FOR THE NINE MONTHS ENDED 30 SEPTEMBER 2021**

The board of directors (the “**Board**”) of SITC International Holdings Company Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) hereby announces certain unaudited operating statistics of the Group for the nine months ended 30 September 2021 and the comparative figures for the corresponding period in 2020.

Revenue generated by the Group’s container shipping and logistics business increased by approximately 77.6% from approximately US\$1,135.1 million for the nine months ended 30 September 2020 to approximately US\$2,015.5 million for the nine months ended 30 September 2021. For the nine months ended 30 September 2021, the Group’s container shipping volume from container shipping and supporting logistics business amounted to 2,248,302 TEUs, representing an increase of approximately 21.2% as compared to 1,855,273 TEUs for the corresponding period in 2020. The Group’s average freight rate from container shipping and supporting logistics business (excluding slot exchange fee income) for the nine months ended 30 September 2021 reached US\$774.1 per TEU, representing an increase of approximately 48.6% from US\$521.0 per TEU for the corresponding period in 2020. Further, revenue generated from the Group’s dry bulk and others business increased by approximately 30.0% from approximately US\$17.0 million for the nine months ended 30 September 2020 to approximately US\$22.1 million for the corresponding period in 2021. As a result, revenue of the Group increased by approximately 76.9% from approximately US\$1,152.0 million for the nine months ended 30 September 2020 to approximately US\$2,037.6 million for the corresponding period in 2021.

The above-mentioned operating data is unaudited and is based on preliminary internal information of the Group, which may differ from figures to be disclosed in the audited or unaudited consolidated financial statements to be published by the Company on an annual or half-yearly basis due to various uncertainties during the process of collating such sales information.
