UNAUDITED OPERATING STATISTICS FOR THE NINE MONTHS ENDED 30 SEPTEMBER 2022

The board of directors (the “**Board**”) of SITC International Holdings Company Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) hereby announces certain unaudited operating statistics of the Group for the nine months ended 30 September 2022 and the comparative figures for the corresponding period in 2021.

Revenue generated by the Group’s container shipping and logistics business increased by approximately 60.2% from approximately US\$2,015.5 million for the nine months ended 30 September 2021 to approximately US\$3,228.1 million for the nine months ended 30 September 2022. For the nine months ended 30 September 2022, the Group’s container shipping volume from container shipping and supporting logistics business amounted to 2,368,742 TEUs, representing an increase of approximately 5.4% as compared to 2,248,302 TEUs for the corresponding period in 2021. The Group’s average freight rate from container shipping and supporting logistics business (excluding slot exchange fee income) for the nine months ended 30 September 2022 reached US\$1,196.2 per TEU, representing an increase of approximately 54.5% from US\$774.1 per TEU for the corresponding period in 2021. Further, revenue generated from the Group’s dry bulk and others business decreased by approximately 52.9% from approximately US\$22.1 million for the nine months ended 30 September 2021 to approximately US\$10.4 million for the corresponding period in 2022. As a result, revenue of the Group increased by approximately 58.9% from approximately US\$2,037.6 million for the nine months ended 30 September 2021 to approximately US\$3,238.4 million for the corresponding period in 2022.

The above-mentioned operating data is unaudited and is based on preliminary internal information of the Group, which may differ from figures to be disclosed in the audited or unaudited consolidated financial statements to be published by the Company on an annual or half-yearly basis due to various uncertainties during the process of collating such sales information.
